**NORTH GRAFTON FISH GAME AND BIRD CLUB, INC.  
INDEMNIFICATION, HOLD HARMELSS, DEFENSE, WAIVER  
RELEASE, ASSUMPTION OF THE RISK AND DAMAGE AGREEMENT**

In consideration of acceptance into membership of the North Grafton Fish, Game and Bird Club, Inc. (hereinafter called the "Club") and the associated authorization to enter and/or use Club areas (hereinafter called the "Premises") which shall include all areas which the Club owns, has a property interest in or to which the Club has a legal right to use and/or occupy (including, but not limited to, shooting ranges, buildings, structures, land/real property), for whatever purpose, including, but not limited to, the use of all types of firearms, crossbows, archery bows, and with acknowledgement of the fact that such firearms, crossbows, archery bows and other permissible weapons are used on and do discharge projectiles on the Premises, the undersigned agrees to the following:

1. The undersigned agrees to indemnify, hold harmless, and defend the Club, its officers, agents and assigns, for and from any and all fault, liability, costs, expenses, claims, demands and/or lawsuits arising out of, related to, or in any way connected with any and all actual or alleged acts or omissions of the undersigned while present on and/or in use of Club Premises including but not limited to any range, building, facility and land.
2. The undersigned further waives, for himself/herself, and his or her heirs, next of kin, assignees, personal representatives, administrator and executors, any and all rights and claims for damages, losses, costs, demands and any other action or claims whatsoever, which he or she may have or which may arise against the Club, its officers, agents or assigns, including but not limited to, any damages to the undersigned's property, illnesses, injury, including mental or emotional distress, and any other, including death, suffered by the undersigned, which may in any way whatsoever arise out of, be related to, or connected with the use of firearms and/or crossbows or archery bows by the undersigned or another on the Club Premises.
3. The undersigned, for himself/herself and his or her heirs, next of kin, assignees, personal representative, administrators, and executives, expressly release the Club, its officers, agents and assigns, from any and all such claims and liabilities, including but not limited to, any claim of actual or alleged negligence on the part of the Club, its officers, agents, servants or assigns.
4. The undersigned acknowledges and agrees that the use of firearms and/or crossbows or archery bows comes with a certain degree of risk, known or unknown. The undersigned expressly assumes the risk of being on Club Premises where firearms and/or crossbows or archery bows are used. The undersigned expressly assumes the risk of discharging firearms and/or crossbows or archery bows by whomever and the firing of live ammunition by the undersigned or another.
5. The undersigned agrees to pay for any and all damages caused by him or her, his or her family, his or her guests, his or her firearms, his or her ammunition or his or her vehicle while on the Club Premises. The undersigned agrees to pay for any and all damages no later than thirty (30) days after receiving an invoice. This agreement and release shall be binding on the undersigned, his or her heirs, next of kin, assignees, personal representatives, administrators, and executors.
6. The undersigned acknowledges that he or she has read all of the foregoing, that he or she fully understands each of the terms contained herein and that he or she has executed this agreement and release voluntarily. The undersigned acknowledges that he or she has received a copy of and has read, agreed to, understood and will, at all times while upon the Club Premises, abide by and obey all state and federal laws regarding firearms, crossbows and archery bows, the range rules, and the SOP of the Club and any future rules the Club may create
